COURSE DESCRIPTION

The purpose of this course is to provide students with a basic understanding of crisis and trauma. Students will develop an understanding of needs following the aftermath of various crises along with appropriate resources and interventions. Students will consider the argument from evil as it relates to crisis and trauma. Students will also discuss compassion fatigue and learn the importance of self-care and emotional health in helping others address and resolve crises.

COURSE STUDENT LEARNING OUTCOMES

At the conclusion of the semester, the student will:

1. Develop a basic understanding of crisis and trauma.
2. Examine a theological perspective for counseling and pastoral care support and intervention in crisis situations.
3. Apply counseling and pastoral care skills for managing and responding to crisis situations.
4. Discuss compassion fatigue and the importance of maintaining emotional health.

COURSE REQUIREMENTS

1. Exams will consist of multiple choice, true/false, short answer, and discussion questions. Students should not assume that the study guide, if one is given, is comprehensive to what will be on the exam. If an emergency prevents a student from taking a scheduled exam, it is that student's responsibility to reschedule with the instructor. If a student misses an exam and does not get preapproval from the instructor and/or cannot provide documentation (doctor's note, police report, death of loved one) they will not be allowed to make up the exam. The exam must be made up within one week of the missed exam. After one week, the student will earn a grade of 0 for the assignment.
2. Students will be required to research a crisis situation and develop an intervention plan for working with the population affected. The research paper should be 8-10 pages, typed, double-spaced, in Times New Roman 12, and adhere to Turabian guidelines. Students may select their topic from a list provided in class. Students must obtain approval from the professor. Students will also be required to record a presentation of their research to be uploaded to a discussion board in Unit 11.
3. Students will be asked to develop a community resource notebook that details the crisis services and appropriate referrals available in the student's community. An assessment of resources that are not available but should be must also be included.
4. Students will complete a reflection paper related to losses they have experienced. This paper should be 3-5 pages, typed, double-spaced, in Times New Roman 12.
5. The final exam for this course will be a paper summarizing the student's approach to crisis intervention from a biblical perspective. This paper should be 3-5 pages, typed, double-spaced in Times New Roman 12 and adhere to Turabian guidelines.
6. Class participation will take place via Discussion Boards. For each unit where a discussion board is required, the student should make his/her initial discussion board post no later than Thursday at 11:59 PM and respond to at least two classmates no later than Sunday at 11:59 PM. The purpose of discussion boards is to allow students and instructors to interact with each other as they engage in the course material. As such, late discussion board posts are not allowed.
7. The final grade for the course will be tabulated according to the following percentage breakdown:

ADDITIONAL COURSE INFORMATION
